RESOLUTION NO. 816

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE IDYLLWILD WATER DISTRICT REQUESTING THE RIVERSIDE COUNTY REGISTRAR OF VOTERS TO CONDUCT THE GENERAL DISTRICT ELECTION TO BE HELD NOVEMBER 3, 2026

WHEREAS, pursuant to California Elections Code Section 10500 et seq., the Idyllwild Water District is required to conduct a General District Election on November 3, 2026, for the purpose of electing members of the Board of Directors; and

WHEREAS, Elections Code Section 10502 authorizes the District to request that the Riverside County Registrar of Voters conduct said election on behalf of the District; and

WHEREAS, the Board of Directors desires that the Riverside County Registrar of Voters render all services necessary for the conduct of the November 3, 2026 General District Election.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Idyllwild Water District as follows:

Section 1.

The Riverside County Registrar of Voters is hereby requested to conduct the General District Election to be held on November 3, 2026, for the purpose of electing Directors whose terms are scheduled to expire.

Section 2.

The District agrees to reimburse the County of Riverside for all costs associated with conducting the election as provided by law.

Section 3.

The Board Secretary is hereby directed to submit all required election documents, notices, district maps, and information requested by the Riverside County Registrar of Voters.

Section 4.

The District hereby determines that the Candidate shall pay the cost of printing and handling the Candidate's Statement pursuant to Elections Code Section 13307.
