

ORDINANCE NO 10

AN ORDINANCE AMENDING, SECTION 170 OF ARTICLE 9 IN ORDINANCE NO 6.

BE IT ORDAINED by the Board of Directors of the Idyllwild County Water District, Riverside County, California, as follows:

Section One.

That Section 170 of Article 9 in Ordinance No. 6 is hereby amended to read;

Service Connections. The District will furnish and install a service of such size and at such location as the applicant requests, provided such requests are reasonable; the service will be installed from the water distribution main to the curb line or property line of the premises which may abut on the street, on other thoroughfares, or on the District right-of-way or easement. Charges for new services are payable in advance and shall be as follows:

5/8-inch	\$55.00
3/4-inch	\$60.00
1-inch	\$85.00
1-1/2-inch	\$120.00
2-inch	\$160.00

For services larger than two(2) inches the applicant will be billed for the actual cost of installation.

Only duly authorized employees or agents of the District will be permitted to install a service connection from the District's main to the customer's premises. The service connection, whether located on public or private property, is the property of the District, unless specifically otherwise provided, and the District reserves the right to repair, replace and maintain it, as well as to remove it upon discontinuance of service.

All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
