ORDINANCE NO. 15

AN ORDINANCE ALTERING BOUNDARIES OF IDYLLWILD COUNTY WATER DISTRICT

ANNEXATION NO. 1959-3

BE IT ORDAINED, by the Board of Directors of the Idyllwild County Water District, Riverside County, California, as follows:

- 1. That Resolution No. 30, a Resolution Proposing the Inclusion in the Idyllwild County Water District of Land Owned by said District, was adopted by said Board on Aug. 5

  1959, which Resolution contained a description of certain District-owned land and proposed its inclusion in the District in accordance with Section 32445, Water Code, State of California.
- 2. That the District-owned land proposed to be included is situate in the County of Riverside, which is the same County in which Territory of the District is situated prior to such inclusion.
- 3. That the Secretary of said District duly set a date for the hearing of said Resolution and caused to be published in the Hemet News, a newspaper printed and published in the County of Riverside, a notice stating that the Resolution had been adopted, describing the lands proposed to be included and notifying all persons interested of the hearing thereon to be held on September 2, 1959, at \_\_8 \_\_o'clock P.M. at the office of the District, Pinecrest Avenue and Idyllwild-Banning Road, Idyllwild, California, the affidavit of which has been presented to and is on file with this Board, and that said Resolution and said notice so published are in the form required by the County Water District Act.
- 4. That all acts and conditions and things required by law to be done precedent to the hearing on said Resolution by this Board have been done and have been performed in regular and in due form and in strict compliance with the provisions of the law authorizing the adoption of said Resolution.

That at the time and place fixed in said notice this Board proceeded to hear all written objections to the proposed inclusion of said District-owned land and \_\_\_\_\_ no \_\_ such objections were received, and upon the hearing on said Resolution and after a full investigation and examination, this Board has found and declared and does hereby find and declare, that said Resolution complies with the requirements of the County Water District Act, and this Board does hereby find and declare the addition to the District of the lands proposed to be added is authorized by said Act and will be for the best interest of the District, and of the lands to be added.
- 6. That the boundaries of the Idyllwild County District shall be, and they are hereby, altered by adding thereto the hereinafter described territory, which territory is hereby annexed to said District, and the boundaries of which territory so annexed are situate in the County of Riverside, State of California, and are more particularly described in Exhibit "A" hereto attached and by reference incorporated herein.
- 7. This Ordinance shall be posted in three public places within the District.

## EXHIBIT "A"

## PROPERTY PROPOSED TO BE ANNEXED TO IDYLLWILD COUNTY WATER DISTRICT

ANNEXATION NO. 1959-3

A portion of the Southwest Quarter of the Northeast Quarter of Section 12, Township 5 South, Range 2 East, San Bernardino Base and Meridian, in the County of Riverside, State of California, more particularly described as follows, to-wit:

Beginning at the Northwest corner of the Southwest Quarter of the Northeast Quarter of said Section 12; thence South 88° 25' 45" East along the Northerly line of the Southwest Quarter of the Northeast Quarter of said Section 12, said line also being a portion of the boundary of the Idyllwild County Water District, 759.85 feet for the true point of beginning which said point is on the present boundary of the Idyllwild County Water District; thence Easterly along said Northerly line, said line also being a portion of the Idyllwild County Water District, 10 feet; thence Southerly on a line at right angles to the above described Northerly line, a distance of 42 feet; thence Westerly at right angles to the last described line, a distance of 34 feet; thence North 28° 10' 26" East about 48.37 feet to the point of beginning, estimated to contain 924 square feet, more or less.
