

ORDINANCE NO. 31

AN ORDINANCE AMENDING ARTICLE 18, SECTION 400 of ORDINANCE NO. 6

AS AMENDED BY ORDINANCE NOS. 9, 11, 16, 27 and 28

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE IDYLLWILD COUNTY WATER DISTRICT AS FOLLOWS:

1. GENERAL METERED SERVICE. Section Bi-Monthly Billing be deleted.

(a) ANNUAL MINIMUM WATER ALLOWANCE AND PAYMENT, is corrected to read as follows:

Accumulative minimum water service is accumulative over a 12 month period, beginning with the June meter reading of each year. The annual minimum charge is due, in advance, on July 1 of each year. May be paid one half in July and the second half not later than January 1, of each year.

(c) CONNECTION AND DISCONNECTION OF SERVICE, is amended to read as follows:

Service commenced before the June meter reading date of each year will have the annual minimum charge prorated at the rate of one-twelfth the annual amount for each month remaining in the service year. Service commenced after the June meter reading date will have the annual minimum charge prorated at the rate of one-twelfth the annual amount for each month remaining in the service year. Service discontinued before the June meter reading date in each year will be adjusted on the basis of the annual minimum payment made. Any unused minimum will be prorated at the rate of one-twelfth of the annual amount for each month of the remaining portion of the service year and refunded to the consumer.

(e) METER READINGS, is amended to read as follows:

Meters will be read two times each year and charges for water use in excess of the annual minimum allowance will be billed in June and November.

Commercial meters will be read in November, March and June and billed accordingly.

AN ORDINANCE AMENDING ARTICLE 18, SECTION 400 of ORDINANCE NO. 6

- (c) CONNECTION AND DISCONNECTION OF SERVICE, is amended to read as follows:

Service discontinued before the June meter reading date in each year will be adjusted on the basis of the annual minimum payment made. Any unused minimum will be prorated at the rate of one-twelfth of the annual amount for each month of the remaining portion of the service year and refunded to the consumer.
- (e) METER READINGS, is amended to read as follows:

Meters will be read two times each year and charges for water use in excess of the annual minimum allowance will be billed in June and November.

Commercial meters will be read in November, March and June and billed accordingly.
